# Introduction

## How It Works

### For Users

1. **Download the app** SRb from App Store or Google Play (free)
2. **Register** with email and password (quick process)
3. **Find a collection point** near you using the integrated map in the app
4. **Start the session** via QR code on the drop-off device
5. **Drop off materials** (PET bottles, cans) at the collection point
6. **Receive SRb tokens** immediately in your digital wallet

### What You Can Do with Tokens

- **Convert to Euro:** Exchange tokens on digital platforms and withdraw to your bank account
- **Environmental donations:** Contribute to reforestation and ocean cleanup projects
- **Governance:** Participate in decisions about the project's future

## Technology

### Technological Infrastructure

SRb uses advanced distributed ledger technologies to ensure:

- **Extreme speed:** Thousands of transactions processed every second
- **Minimal costs:** Fees below €0.01 per transaction

- Launch in Spain, France, Germany
- Multinational partnerships
- Mature ecosystem with third-party applications

# Environmental Impact

Every action on SRb generates measurable impact:

Action	Savings	Equivalent
Recycle 1 PET bottle	Energy for 25 min PC	~30 grams CO2
Recycle 1 can	Energy for 2 hours TV	~170 grams CO2
Recycle 1 ton PET	5,774 kWh energy	13 trees saved

The app displays your personal impact in real-time: CO2 saved, trees saved, energy conserved.

# Frequently Asked Questions

## How do I earn tokens?

You earn 1 SRb token for each bottle or can recycled. The system applies bonus multipliers based on time slots, frequency, and loyalty.

## How much are tokens worth?

The value is determined by the market on exchange platforms. Tokens represent a reward for recycling actions, not a speculative investment.

## Is the app free?

Yes, completely free. There are no costs for download, registration, or using collection points. The only minimal fees are those of the underlying technology (approximately €0.001).

## Is it safe? Is my data protected?

Yes. SRb is GDPR compliant. Personal data is encrypted and never shared with third parties. The technology ensures pseudonymity: transactions are public but not linked to your identity.

## Where can I use tokens?

You can convert tokens to Euro on exchange platforms, donate them to environmental causes, or use them to vote on project governance decisions.

## Are there recycling limits?

There is a standard daily limit of 100 units per user, which can increase for consistently active users. This ensures fairness and system sustainability.

## What if I lose my phone?

If you saved your recovery phrase (12 words), you can restore your wallet on a new device. Without the recovery phrase, tokens are unrecoverable - treat it like your house keys.
